I. Purpose

The purpose of this policy is to set forth regulations and criteria regarding distribution of information about trips in or on school property.

||. Definitions

- A. <u>School Sponsored Trip</u> means a field trip as defined in Harford County Public Schools ("HCPS") Procedure entitled *Field Trips*, or a trip which is ancillary to an approved extracurricular or club activity.
- B. <u>Non-sponsored trip</u> means any trip planned, or attempted to be planned, by persons in a school, other than a school sponsored trip.

III. Policy Statement

- A. Schools may permit as to school sponsored trips:
 - I. The posting of information regarding such trips; and/or
 - 2. Distribution of info1mation regarding such trips; and/or
 - 3. Meetings regarding such trips.
