ANSWER: No.

9. **QUESTION**: Is there any liquid dated damages if not completed by Dec 31

ANSWER: No.

10. **QUESTION**: Is the MBE only 15%

ANSWER: Yes, each project has a MBE goal of 15%.

11. **QUESTION**: Page 127 HOT mix asphalt pavement said paid by SY item C-3 in bid paid for by ton if it is SY price what is the depth

ANSWER: Refer to #7 of this addendum, 4-inch depth.

12. **QUESTION**: Page 41 Bid form ask for an asphalt escalation amount is that the May posted AC price. Where is Section 10 in spec?

ANSWER: Refer to Page 34, Specifications, Section #10 Asphalt Rate Adjustments.

13. **QUESTION**: Page 139 Special Conditions 1-F calls for 6 ft. chain link fence around entire site what are the limits

ANSWER: The limit is around the area of the new parking lot pavement area, SWM and Storm Drain construction, it does not include the resurfacing alternate areas.

14. **QUESTION**: Detail call for 7 inch curb gutter you show 6 inch on plans

ANSWER: The 7-inch curb is in the pavement returns that are located in the road right of way. The 6-inch curb is for all the curb on the school property.

15. **QUESTION**: Dublin ES – C01 Hash area shown on existing lots is that for patches if so what depth

ANSWER: Refer to the paving section for full depth pavement at each school.

16. **QUESTION**: Dublin ES – C01 Hash area back lot top left side of lot are you doing anything there **ANSWER**: The gravel area will be removed, and new full depth pavement will be installed.

17. QUESTION: Dublin ES – C01 Show two play lots to be removed are we moving equipment as wellANSWER: Yes and disposing the play equipment.

18. **QUESTION**: Dublin ES – C01 Only show 103 LF of curb removal is that all? Depressed area out front and at hump area

ANSWER: The curb removal is now shown on the demolition drawings.

19. **QUESTION**: Dublin ES – C01 Is the hump shown both jobs bituminous or concrete are the humps the 6 inch concrete on detail C02

ANSWER: Both humps are to be the 6-inch concrete pavement section.

20. **QUESTION**: Dublin ES – C02 Both locations in full depth to refresh stone base there is none what is the depth of stone base

<u>ANSWER</u>: Dublin has stone sub-base and the surface will be refreshed and compacted. George Lisby does not have stone sub-base and the project calls for 6-inch CR-6 to be installed in the patching areas.

21. QUESTION: Note for Goerge Lisby call for 1.5 inch milling plan C01 said 1 inch milling

ANSWER: The George Lisby mill will be 1.5 inches and resurface with 1.5 inches of surface course.

22. **QUESTION**: Dublin ES – SWM 08 Shows pond 1&2 SC1 shows pond 3&4 is it 4 total

ANSWER: The SC1 drawing now shows only 2 ESD to be installed.

23. **QUESTION**: Dublin ES – SWM 08 You show double SSF in two locations

ANSWER: One line was SSF, the other line was safety fence which has been removed.

24. **QUESTION**: Dublin ES – SWM 08 Show 270 LF SFOP scale about 55 LF SC1 shows 93 LF of SFOP

ANSWER: The quantities have been revised.

25. **QUESTION**: Dublin ES – SWM 1 Only shows one play lot with small amount of sidewalk **ANSWER**: Refer to the site plan for the play area and the sidewalk to be installed.

26. **QUESTION**: Dublin ES – SC 1 Changes location and more sidewalk

ANSWER: Refer to the site plan for the play area and the sidewalk to be installed.

27. **QUESTION**: Dublin ES – SC 1 Also show two more play lots with walks

ANSWER: Refer to the site plan for the play area and the sidewalk to be installed.

28. **QUESTION**: Dublin ES – SC 1 What is going in play lots mulch how much

ANSWER: The plat lots are not part of this project.

29. **QUESTION**: Dublin ES – SC 1 Are the parking areas on Grange Dr full depth or mill overlay pipe is going thru some of it

ANSWER: The Grange Dr parking area is to be full depth pavement installation.

30. **QUESTION**: Dublin ES – SC 1 Are we widening main lot is it full depth

ANSWER: The main parking lot is to be widen using a full depth paving section and is to be included in the resurfacing alternative price.

31. QUESTION: Dublin ES - SC 1 Plan SC 4 in Dublin section is for George Lisby

ANSWER: Drawings have been rearranged.

32. **QUESTION**: Dublin ES – SC 1 Is the 7 ft walkway going to play lot the same paving section as lot

ANSWER: Refer to the site plan and section for the sidewalk to be installed.

33. **QUESTION**: George D. Lisby – C01 Does not show removal of bituminous at existing HC parking areas upper left corner of existing lot

ANSWER: The removal of the bituminous pavement and curbing at the existing HC parking area is now shown on the demolition drawings.

34. **QUESTION**: George D. Lisby – C02 does not show removal of sidewalk at entrance to lot

ANSWER: The removal of the sidewalk is now shown on the demolition drawings.

35. **QUESTION**: George D. Lisby – C02 Does not show sidewalk replacement at the existing inlet I-1 we tie into across from South Dr

ANSWER: Drawing now shows the sidewalk replacement.

36. **QUESTION**: George D. Lisby – C0-4 Show sign 1 no parking in access aisle sign on entrance road should that be sign 13 no parking

ANSWER: The sign has been changed to sign no 13.

37. **QUESTION**: George D. Lisby – SC-1 Do we need SCE with a wash rack

ANSWER: Yes, the wash rack is required.

38. **QUESTION**: George D. Lisby – SC-1 Show 265 LF of silt fence on pavement in front of curb to remain is that needed

ANSWER: Yes.

39. **QUESTION**: Who will be responsible for the construction stakeouts at Dublin & GDLE? Will the contractor be responsible or is that another thing Frederick Ward is doing?

ANSWER: Frederick Ward will be providing the construction Stakeout.
