Background Information

The Board of Education of Harford County charts annually a calendar committee to make recommendations on future school schedules. The Board established on April 15, 2002, the makeup of the committee. For the fourteenth year, the Board of Education has directed that a Board member serve as an ex-officio member of the calendar committee.
