

# BOARD OF EDUCATION OF HARFORD COUNTY

## PROPOSED 2021-2022 HCPS CALENDAR

September 21, 2020

### **Background Information:**

Each year, the Board of Education of Harford County appoints a Calendar Committee to make recommendations for the “out year” Harford County Public Schools calendar. The 37-person committee – composed of representatives from the community and the school system – is charged with recommending a proposed calendar for the upcoming school year. The committee meets and attempts to reach consensus on the proposed “out year” calendar during the month of August. The proposal is forwarded to the Superintendent who reviews it and makes a recommendation to the Board to adopt the calendar as proposed by the committee or with suggested changes. The Board receives the Superintendent’s proposal at a public business meeting, holds the proposal over for at least 60 days to allow for public comment (the proposed calendar is placed on the HCPS website) which the calendar committee utilizes to present the calendar as proposed or with suggested changes, and then the Board votes to adopt a calendar for the “out year” at a subsequent meeting

### **Discussion:**

This year, the membership of the 2021-22 Calendar Committee (roster attached) was approved by the Board of Education at its August meeting. The committee met virtually on August 19, 2020 and reached consensus on a proposal for the Superintendent’s review. The 180-day student/190-day teacher calendar (grid attached) contains the following features:

- New teachers report on Thursday, August 26, 2021.
- Returning teachers report on Monday, August 30, 2021.
- School begins for students (K through grade 12) on Wednesday, September 8, 2021.
- School begins for pre-kindergarten students on Friday, September 10, 2020.
- Schools and offices are closed for one-day holidays on:
  - Monday, September 6, 2021 (Labor Day)
  - Tuesday, September 7, 2021 (Rosh Hashanah)
  - Thursday, September 16, 2021 (Yom Kippur)
  - Monday, January 17, 2022 (Martin Luther King, Jr. Day)
  - Monday, February 21, 2022 (Presidents Day)
  - Monday, May 30, 2022 (Memorial Day)
- Schools and offices are closed for Thanksgiving break Thursday, November 25, and Friday, November 26, 2021, with an early dismissal for schools and offices on Wednesday, November 24, 2021.
- Schools are closed for winter break from Friday, December 24, 2021, through Friday, December 31, 2021, with an early dismissal for schools and offices on Thursday, December 23, 2021.
- Schools and offices are closed for spring break on Friday, April 15 through Monday, April 18, 2022, with an early dismissal for schools on Wednesday, April 13, 2022.
- Staff Professional Development will be held before the start of school on Monday, August 30, through Friday, September 3, 2021. It will also occur on Friday, October 15; Friday, November 12; Thursday, April 14; Tuesday, April 19; on early dismissal days throughout the school year and one day after the last day of school.
- Three-hour early dismissal days for all schools are scheduled for Thursday, October 14; Friday, November 5; Friday, January 14; Friday, February 18; Friday, March 18; Wednesday, April 13; and Friday, May 27.
- Three-hour early dismissal days for all schools and offices are scheduled for Thursday, November 11 (in observance of Veterans Day); Wednesday, November 24; and Thursday, December 23.

**With no inclement weather makeup days utilized:**

- The last day for pre-kindergarten students is Wednesday, June 8, 2022.
- The 180<sup>th</sup> student day for those in kindergarten through 11<sup>th</sup> grade is Friday, June 10, 2022.
- The 190<sup>th</sup> teacher day is Monday, June 13, 2022.

NOTE: The Calendar Committee designed the calendar planning for the last day of school in order to allow for inclement weather make-up days. If all inclement weather makeup days are utilized, Monday, June 20, 2022, is the last student day. The last teacher day is Tuesday, June 21, 2022.

- There are six inclement weather makeup days built into the calendar. They are scheduled for Monday, June 13; Tuesday, June 14; Wednesday, June 15; Thursday, June 16; Friday, June 17; and Monday, June 20, 2022.
- A Staff Professional Development makeup day is scheduled for Tuesday, June 21, 2022.

**Superintendent's Recommendation:**

The Superintendent recommends the Board approve the proposed 2021-2022 school calendar as presented by the Calendar Committee.
