

ADDITION/DELETION OF SPORTS PROCEDURE

- 1. A proposal is submitted to the Athletic Legislative Committee (ALC) by the schools.
- 2. The ALC reviews and discusses the proposal providing a recommendation for the approval of the addition/deletion of the sport.
- 3. The addition/deletion of a sport then requires the approval of the General Curriculum Committee and the Superintendent of Schools.


