## DECISION ON AWARD OF CONTRACT HOMESTEAD/WAKEFIELD ELEMENTARY SCHOOL REPLACEMENT

### **April 24, 2023**

#### **Background Information:**

Construction bid documents for the Homestead/Wakefield Elementary School Replacement project were issued and advertised during the months of February/March 2023. This work includes trade packages that are related to the new elementary school facility. The multiple prime construction management process is being used to bid this project. Funding in the amount of \$98,505,240.00, phased over four (4) fiscal years (FY22, FY23, FY24, [deferred] and FY25), will be provided by the County and State for this project. Bids were received and opened on March 9, 2023.

On March 27, 2023, the Board of Education approved the award of nine (9) contracts for the Homestead/Wakefield Elementary School Replacement for the base bid proposals including alternates 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, and 19 in the amount of \$59,448,286.00.

On March 30, 2023, the approved 07A prime contractor, Eastcoast Exteriors, sent correspondence to Harford County Public Schools asking permission to withdraw their bid package due to a scope discrepancy. Correspondence from Eastcoast Exteriors requesting the withdrawal and correspondence from the Construction Manager, J. Vinton Schafer, regarding the timeline and sequence of events are attached to this report.

#### Discussion:

Four (4) contractors submitted bids for the 07A - Roofing bid package and nineteen (19) alternates. CitiRoof Corporation submitted the next responsive and responsible bid. The sum of the base bid is \$4,939,737.00, and the sum of the recommended alternates is \$137,700.00 for a total bid amount of \$5,077,437.00. The bid package tabulation sheet listing the alternates is attached. The attached table illustrates the bid package, the contractor who submitted the low responsible bid, and the bid amount for their base bid and participation in the following recommended alternates: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, and 19. CitiRoof Corporation has done many successful projects for Harford County Public Schools in the past.

#### Superintendent's Recommendation:

The Superintendent of Schools recommends that the Board of Education rescind the award of contract to Eastcoast Exteriors, and approve the award of 07A Roofing contract to CitiRoof Corporation for the Homestead/Wakefield Elementary School Replacement for the attached base bid proposal including alternates 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, and 19 in the amount of \$5,077,437.00.

Dear Mr. Miller:

J. Vinton Schafer Construction, LLC is in receipt of the notice that the apparent low bidder for the 07A Contract Package, East Coast Exteriors, is requesting to withdraw their bid. Please see the below outline of the discussions leading up the this decision by the O7A Bidder.

- 3/9/2023 Bids were received and opened by HCPS with JVS in attendance. East Coast Exteriors had the lowest bid. JVS and HCPS noted the significant spread between the low bid and the next lowest bid.
- 3/10/2023 JVS reached out to East Coast Exteriors to confirm their bid and to set up a meeting to review the 07A scope package with the bidder. We received no indication from the bidder that there was a concern with their pricing.
- 3/13/2023 JVS met with East Coast Exteriors and reviewed the 07A scope of work in full including review of the scope sketches provided with the contract packages. East Coast confirmed that they had reviewed the scope and had the scope of work covered in their pricing. At that time, they reacknowledged the bidding documents in their entirety including the Addenda, Alternates, and Prevailing Wage Requirements.
- 3/17/2023 The Apparent Low Bidder letter was sent from HCPS to East Coast Exteriors.
- 3/23/2023 JVS discussed with HCPS the contractors that had not provided MBE documents for the upcoming BOE meeting on 3/27/23. JVS reached out to East Coast Exteriors to get clarification on the status of the MBE documents. We were advised that they had been sent via courier and received a follow-up response with a copy of the documents sent.
- 3/23/2023 (5:09pm) JVS received an email from East Coast Exteriors requesting documentation regarding the budgeting for the 07A Contract Package.
- 3/27/2023 HCPS advised that the MBE documentation provided from East Coast Exteriors was incomplete. JVS reached out to East Coast Exteriors and provided clarification for the required documentation which East Coast was able to provide. East Coast Exteriors was approved as the low bidder by the BOE.
- 3/28/2023 Notice to Proceed letters were provided by JVS for all approved bidders.
- 3/29/2023 JVS requested clarification regarding the requested documentation for the 07A budget for the bonding company and provided the estimate to East Coast Exteriors from the latest JVS Estimate provided to HCPS.
- 3/30/2023 East Coast Exteriors requested clarification regarding the estimate to confirm that the estimate was based on the 07A SOW and not the Div. 07 Specification. JVS confirmed that the estimate was based on the scope package as included in the bidding documents. HCPS later received notice from East Coast Exteriors that they were requesting to withdraw their bid.

Throughout the conversations held with East Coast Exteriors from bid opening to the receipt of withdrawal, the bidder was confident in the pricing provided and provided every indication that they had included the full scope of the work. It is the understanding of J. Vinton Schafer that it was the concern of the bonding company that their was such a discrepancy between the low bid and the 2<sup>nd</sup> lowest bid, as well as the large discrepancy between the low bid and the project estimate for this scope of work that resulted in the decision by East Coast Exteriors to request a withdrawal of their bid for this project.
