Examples of commodity food products are beef, pork, chicken, and cheese.• The commodity food products require processing, which converts the raw commodity into a variety of convenient, ready-to-use end products such as: hamburgers, meatballs, chicken patties, chicken nuggets, and mozzarella sticks.• HCPS solicited RFP #20-DSS-034, approved by the board on January 11, 2021, which is primarily used for our commodity products.• This contract will be used on an as-needed basis to meet any commodity processing needs that cannot be filled by HCPS RFP #20-DSS-034.• The total annual expenditure will depend on the needs of the district and funding availability and is expected to exceed \$100,000.• Purchases made utilizing this contract will be within approved budget limits.
