## I. Purpose

The purpose of this policy is to set forth the position and criteria of the Board regarding student access to telehealth appointments with parent/guardian consent.

## II. Definitions

For the purpose of this policy, the following definitions apply:

A. Telehealth Appointment – A mode of delivering healthcare services through the use of telecommunications technologies by a health care practitioner to a patient at a different physical location than that of the health care practitioner.

## **II.** Statement of Policy

- A. The Board is committed to ensuring the school system is in compliance with House Bill (HB) 522 Public Schools Telehealth Appointments State Guidelines, Policies, and Access (Md. Code, Education 4-143)
- B. Middle and High School students will have access to telehealth appointments during the school day as long as all criteria has been met, including the presence of a parent/guardian and a completed consent form submitted to the school from the parent/guardian.
- C. Criteria for the allowance of telehealth appointments are outlined in the accompanying procedure to this policy, <u>Student Telehealth Access Procedure</u>
- D. Reference to this policy and its accompanying procedure will be made in the student/parent handbook.
