Restricted Fund

Program Overview

The Harford County Public Schools restricted fund is comprised of school-based and systemic projects funded through federal, state, local government grants as well as donations from businesses and organizations. The programs are "restricted" as the funds can only be administered to serve specific schools, students, curriculum content areas, and educational initiatives. The Coordinator of Grants, Business, and Community Partnerships is responsible for administrative leadership in developing, acquiring, implementing, managing and monitoring grants, partnerships and donations for Harford County Public Schools.

Accomplishments - FY 2016

- Developed and submitted new Junior Reserve Officer Training Corps (JRTOC) proposal in partnership with the Maryland's Military Officers Association of America (MOAA) (Board Goal 1)
- Partnered with the Early Childhood Office to develop and secure the \$734,000 Pre-Kindergarten Expansion Grant through the Maryland State Department. Deerfield Elementary and William Paca/Old Post Road Elementary schools, increased the Pre- K program to full day. An additional 40 four year olds now have access to high-quality early childhood education (Board Goal 1)
- Developed and secured \$50,000 Science, Technology, Engineering and Math (STEM) grant through the Maryland State Department of Education to provide support for school-based and systemic STEM initiatives (Board Goal 1)
- Secured National Math Science Initiative (NMSI) worth \$63,00 through The Boeing Company to support increasing the number of students successfully participating in STEM Advanced Placement courses at Aberdeen High School (Board Goal 2)
- Partnered with the HCPS Office of Equity and Cultural Proficiency and the Y of Central Maryland to secure \$300,000 the Magnolia Middle School Vikings After School Team (VAST) through the Maryland State Department of Education 21st Century Community Learning Center program (Board Goal 2)
- Worked with the United Way's Harford County Community Partnership Board to secure a Family Stability Case Manager at Magnolia Elementary Judy Center. The program is worth \$150,000. (Board Goal 2)
- Supported Office of Equity and Cultural Proficiency to secure sponsors for the young women of promise conference (Board Goal 1)
- Partnered with Office of Physical Education and Health to secure \$10,000 grant from Fuel Up to Play 60 designed to support Deerfield Elementary's health and wellness activities (Board Goal 4)
- Assisted schools in securing donors for field trips (Board Goal 2)
- Increased partnerships with organizations and businesses joining the HCPS Community Partnership network providing donations, classroom support, mentoring opportunities, and school supplies for schools (Goal 2)
- Provided broad- based collaboration and communication with HCPS non-public school partners (Goal 2)
- Prepared Title II A Highly Qualified Teacher application, and supported the development and submission of all other federal formula funds to align with HCPS Master Plan (Goals 1 and 2)
- Reviewed over 150 community organizations' fliers for distribution to students in schools (Goal 2)
- Represented HCPS on community-based boards including: Chamber of Commerce Education Committee; United Way Harford County Community Partnership Board; Early Childhood Advisory Council (Co-Chair); Northeastern Maryland Technology Council; the Local Management Board for Children; and Susquehanna Workforce Network Youth Advisory Board (Board Goal 2)
- Worked on behalf of HCPS in partnership with Aberdeen Proving Ground's senior staff to offer Community Partnership for Education event at Aberdeen High School (Board Goal 2)

Goals - FY 2018

- Expand the funding capacity of HCPS in support of initiatives and programs that will increase student achievement (Board Goal 1)
- Provide leadership in the grant program implementation and ensure all programs are aligned with Central and School Improvement Planning priorities (Goals 1, 2, 3, and 4)
- Increase partnerships with community organizations and businesses working to support HCPS and schools (Goals 1 and 2)

Objectives - FY 2018

- Develop and secure grants and donations that align with central office and school-based administrators school improvement priorities (Board Goal 1)
- Support program managers, and work with grants accountant, to manage and monitor the successful implementation of grant programs, including progress reports, fiscal reports, and annual evaluation reports (Board Goal 1)
- Represent HCPS by participating in community outreach activities and various community-based boards, including Aberdeen Proving Ground related activities (Board Goals 1 and 2)
- Work with Coordinator of School Improvement and ensure new Every Student Succeeds Act (ESSA) entitlement
 grants are developed and aligned with central office and school improvement planning (Board Goal 1 and 3)
- Work to identify businesses and organizations offering to assist with students' capstone projects and opportunities to participate in the workplace experiences (Board Goal 2)
