Performs work required for the routine cleaning, maintenance and upkeep of buildings, grounds, and equipment and to be responsible for the direction and follow-up of custodial personnel in the performance of their work.

DUTIES AND RESPONSIBILITIES	These items are intended only as examples of the various types of job duties to be performed. The omission of specific duties does not exclude them from the position if the work is a similar, related, or logical assignment to the position.
INCLUDE	<ul> <li>Performs all custodial functions required to maintain good housekeeping including sweeping, scrubbing, waxing, polishing, deodorizing, and collecting and removing trash.</li> <li>Assigns, directs, and follows-up on the work of custodial employees.</li> <li>Inspects work of assigned personnel and directs corrective measures to secure satisfactory performance to meet established standards.</li> <li>Conducts inventory, requisitions supplies and equipment, and is responsible for the security of the items.</li> <li>Reports needed repairs.</li> <li>Instructs employees in the methods and use of materials and equipment as required for the performance of their work and maintains established standards.</li> <li>Executes rules and regulations and safety rules.</li> <li>Maintains operating records as requested.</li> <li>Supervises preparation for special events.</li> <li>Checks time cards.</li> <li>Understands and performs basic boiler and rooftop unit maintenance and operation.</li> <li>Responds and assists during emergency situations including, but not limited to, inclement weather assignments, vandalism, and emergency repairs.</li> <li>Performs other work-related duties as assigned.</li> </ul>

REQUIREMENTS	<ul> <li>High school diploma or GED.</li> <li>Able to read, understand, and apply written instructions, including work procedures, product labels, material safety data sheets, and equipment instruction manuals.</li> <li>Two years of experience in a custodial, mechanical trade or related area, preferred.</li> <li>Physically able to perform the essential functions, with or without reasonable accommodations, of the everyday responsibilities including handling of mops, buckets of material weighing up to 50 pounds, and the ability to climb ladders in excess of 15 feet as well as erect scaffolding, plus utilization of back mounted vacuums.</li> <li>Must be able to assist with lifting and moving heavy objects over 50 pounds, such as teacher desks, file cabinets, and other furniture equipment.</li> </ul>
