Dear Members of the School Board:

I recently had a very troubling conversation with an \_\_\_\_\_ who attends \_\_\_\_\_ School. I understand that this school now allows sexually developed \_\_\_\_\_ students to enter the \_\_\_\_\_ locker room and observe the \_\_\_\_\_ changing for gym.
