The omission of specific duties does not exclude them from the position if the work is a similar, related, or logical assignment to the position.</li> <li>Provides speech/language therapy to students with approved IEP/IFSP's in an appropriate setting, i.e., therapy room, classroom, natural environment, etc.</li> <li>Serves as a member of an IEP/IFSP team when students receiving services are being discussed.</li> <li>Interprets test results and writes assessment reports.</li> <li>Participates in the development of IEP/IFSP's.</li> <li>Consults with parents/caregivers, teachers and others as appropriate concerning students' speech/language needs.</li> <li>Interprets external agency reports and shares information with teachers, administrators, school health personnel, etc.</li> <li>Updates administrators on issues pertaining to special education policies and procedures.</li> <li>Completes appropriate special education forms.</li> <li>Maintains documentation of services provided to students.</li> <li>Completes Medicaid billing encounter forms.</li> <li>Performs other work-related duties as assigned.</li> </ul>
