I. Purpose

The purpose of this policy is to authorize the acceptance and procurement of contributions, whether financial or in-kind, to Harford County Public Schools (HCPS) from persons or entities external to the school system.

II. Definitions

- A. <u>Solicitation</u> means to procure monetary gifts, donations, or in-kind gifts from sources external to HCPS.
- B. <u>Grants</u> means funds received from private entities or persons subject to certain conditions or requirements.
- C. <u>Advertising</u> means a communication by any person or entity external to HCPS either in writing or by voice and in any format which:
 - 1. Promotes or encourages the sale or use of an item or service; or
 - 2. Recognizes a private person or entity for any financial or in-kind contribution which the person or entity has made to HCPS whether for or without consideration.
- D. <u>Monetary gifts/donations</u> means funds received for no consideration.
- E. <u>In-kind gifts</u> means real or personal property other than money received for no consideration.
- F. <u>Sponsorship</u> means the provision of money or in-kind gifts from a private person or entity to support a school or HCPS activity or function.

III. Rules and Requirements

A. The Board authorizes the solicitation of grants, sponsorships, advertising, monetary gifts/donations, or in-kind gifts, to enhance resources available to HCPS. Any advertising solicited pursuant to this policy is subject to the Board's Advertising policy.



- B. The Board authorizes acceptance of monetary gifts/donations, grants, and in-kind gifts and sponsorships as defined above.
- C. The Board prohibits either solicitation or acceptance of grants, advertising, monetary gifts/donations, sponsorships or in-kind gifts when such solicitation or acceptance is inconsistent with the educational mission of HCPS.
