- I. Special Education Pete Schlehr and Kim Heeter
  - A. Develop IEP's design and implement specially designed instruction.
  - B. Collaborate with others collect data and progress toward the goals, providing aids/services.
  - C. Provide testing accommodations during assessments.
  - D. Coordinate scheduling of IEP meetings and maintain IEP compliance (federal, state, and local).
- II. Physical Therapist Carly Stock
  - A. Focus on access and participation in school.
  - B. Goal areas gross motor, functional mobility, postural control, self-management.
  - C. Service models vary based on student.
  - D. Can be delivered by IEP or 504.

- III. Occupational Therapist Christina Cortese
  - A. Medical vs Educational
  - B. Fine motor strength, grasp to manipulate objects, using two hands, dexterity.
  - C. Visual block building, copying letters, cutting out pictures.
  - D. Sensory help student reach alertness to attend in class.

Q. How do you go about getting an IEP for your child?

A. The child is referred by a parent requesting an IEP meeting or is referred by Student Services.

Q. Can an IEP be taken away due to goals being met?

A. Yes, if they don't require special instruction; however, they would be moved to a student services plan for regular check-ins.

Q. What percentage in Harford County have an IEP or 504?

A. 15%

- Q. What guidance is given for students graduating high school?
- A. A transition resource itinerant is helpful.
