 - a. Special Education has grown 14% since the 21/22 school year,
 - b. More than 80% of those students are in general education classes.
 - c. STRIVE classrooms have been added to Southampton and Deerfield.
 - d. Learning Together was added to Emmorton.
 - New STRIVE programs at Abingdon, Forest Hill, Hickory and Roye Williams.
