Stormwater and Drainage Improvements at Joppatowne High School

TO: ALL BIDDERS

This addendum is issued as part of the Bid Documents for the above-referenced project. The changes incorporated into this addendum shall be considered as part of the documents and shall supersede, amend, add to, clarify, or subtract from those conditions shown in the original documents. The **B**idder shall take care to incorporate modifications related to the work.

1. **QUESTION**: Are we supposed to use the Redline E&S plans that were signed in 2020, 5 years prior to the grading plan in 2025 as they show different E&S controls within the project area which seems to be larger in the redlined plan C-21 to C-23.2?

ANSWER: No, use the current plans. The redline plans are included because they were part of the grading permit process with the county so the county can see what had changed since 2020. Use the current 2025 plans for E&S locations and LOD.

2. **QUESTION**: It is noted on the original E&S plans that note 10 say we need to jet and vac the existing storm drain, but it is not noted on the Redline E&S. Is this still to be completed?

ANSWER: Yes, upon completion of the work, the existing lines shall be jetted.

3. **QUESTION**: There are 6 places that it notes to seal existing storm drain joints on a 12" and 15" line. How is this intended on being completed as you can fit inside the pipe. Do you want those joints excavated and repaired from the outside?

ANSWER: Yes, they shall be excavated and repaired.

4. **QUESTION**: At the 3 locations it calls out for a T connection, is a field connection to the existing pipe, okay?

<u>ANSWER</u>: The connections shall be made using an Inserta-Tee brand connection or approved equal which is installed per manufacturer recommendations. Field connections of other items will not be allowed. The use of a hole saw is required for a water tight fit. See manufacturer website for details and specifications for connection HDPE to Concrete/CMP.

5. **QUESTION**: What type of inlet is needed to replace 06B-IN? Site plan says Type E, but the profile plan says Type K?

<u>ANSWER</u>: The note on the plans indicates that the existing Type E inlet is to be removed. The existing Type E inlet will be replaced with a Type K inlet.

6. **QUESTION**: The plans call for 3 places where you want T-Junctions. Not sure what you mean by this since we are going from concrete/cmp to HDPE. Do you have a detail of what you want? I see you have a Junction box at 08-JB. Would that be a better fit for this application?

ANSWER: Refer to #4 of this Addendum.

7. **QUESTION**: I see you have a Junction box at 08-JB. Would that be a better fit for this application?

ANSWER: A SHA MD386.11 junction box or approved equal can be used for 08-JB.
