This Addendum is issued in response to prospective offeror's inquiries and to add/clarify verbiage in the RFP document.

1. **RFP DUE DATE CHANGE: DUE DATE: January 30, 2026, 12:00 PM**

The RFP Due Date and Time has been changed from January 28, 2026, 12:00 pm. **The Due Date and Time is now January 30, 2026, 12:00 pm.**

2. **ADD:** Page 31, Section 26

26.7 Additional samples may be requested if deemed necessary for evaluation by HCPS.

26.8 Samples are not required for exact matches to items on the Cost Proposal Form (Addendum #2, Attachment C) but must be submitted for any alternative products or any products offered under the Additional Item Availability Proposal Form (Addendum #2 Attachment D)

3. **DELETE:** Page 25, Section 12.1 –

12.1 HCPS requires that participating respondents have been in the business for at least ten (10) years consulting on retirement plans. All respondents shall submit the number of years providing this type of service under the current business name and contact name on company letterhead. Respondent(s) who cannot demonstrate to the satisfaction of HCPS that they have had similar experiences or fail to provide this documentation may deem your proposal non-responsive.

4. **QUESTION:** We rep **other** commodity clients who process in Maryland: **Trident/ FISH, Conagra/ CHEESE** pizza, **Brookwood Farms/ PORK** and **TURKEY, Cargill /EGGS** and **Classic delight /CHEESE** in Maryland as well.

Since they are not listed on the Cost Proposal specifically -- and may or may not have items that match up against what's on here -- should they be submitting bids to you?

**ANSWER:** Yes, Offerors proposing items that are not listed specifically on the Cost Proposal Form (Addendum #2 Attachment C) shall utilize the "Additional Item Availability Proposal Form" (Addendum #2 Attachment D) for the items they wish to include with their proposal.

5. **QUESTION:** I looked through all the documentation and links and couldn't find the quantity or manufacturer/model for this intended procurement. Would you please clarify this?

**ANSWER:** Estimated quantities are included on the Cost Proposal Form (Addendum #2 Attachment C)

6. **QUESTION:** Feeser's inc is interested in bidding this opportunity, can you please send me the previous bid tabulation with winning prices/vendors?

**ANSWER:** Please see Addendum #2 Attachment B 20-DSS0924 Commodity Food Processors RFP Tabulation

7. **QUESTION:** The RFP notes a link to FDA acceptable processors ([www.fns.usda.gov/usda-foods/npa-approved-processors](http://www.fns.usda.gov/usda-foods/npa-approved-processors)) but that link is not valid. Would any of this be clarified in the online Pre-Bid Conference on 1/8? I can virtually attend. The RFP indicates that all questions need to be submitted ahead of that. Please let me know if I need to do that regarding what we discussed. Thank you.

**ANSWER:** Please reference Addendum #1 Question #1

8. **QUESTION:** Are electronic signatures ok for all signature pages for this RFP?

**ANSWER:** Yes

9. **QUESTION:** Regarding Line Item # 41 "Pizza, Mickey's Cheese Pizza," the code number referenced (8F) is incomplete.

Harford currently uses G16C16S08F Whole Grain Cheese Pizza 8-cut

Mickey's also offers S16C16S08F Cheese Pizza 8-cut (standard crust NOT WG)

Can you clarify which item the spec is referencing?

**ANSWER:** **G16C16S08F is current product used by HCPS.**

10. **QUESTION:** I tried to sign in via teams and also by phone but was not successful. Will there be a recording of the meeting posted on Teams for me to watch?

**ANSWER:** No

11. **QUESTION:** Do you use any BBQ Pork, BBQ Turkey or BBQ Chicken products? We represent Brookwood BBQ, an authentic BBQ producer out of North Carolina. They are also a commodity processor. I would love to sample you on these items and follow up with a tasting at once of your schools to judge the student's opinion.

Along those same lines, we now represent Lamb Weston. I would love to show you some of their products and also do a tasting.

**ANSWER:** Offerors proposing items that are not listed specifically on the Cost Proposal Form (Addendum #2 Attachment C) shall utilize the Additional Item Availability Proposal Form (Addendum #2 Attachment D) for the items they wish to include with their proposal.

Offerors proposing items that are not listed specifically on the Cost Proposal Form (Addendum #2 Attachment C) shall utilize the "Additional Item Availability Proposal Form) (Addendum #2 Attachment D) for the items they wish to include with their proposal.
15. **QUESTION:** If HCPS will consider additional commodities not mentioned on the initial pricing sheet, will they needed to be added to the bid as an addendum, or can we just bid the items on the blank pricing sheet?
- ANSWER:** Offerors proposing items that are not listed specifically on the Cost Proposal Form (Addendum #2 Attachment C) shall utilize the "Additional Item Availability Proposal Form) (Addendum #2 Attachment D) for the items they wish to include with their proposal.
16. **QUESTION:** For the **RFP 26-SRS-008 Commodity Food Processors bid**, could you please confirm which column you would like us to use for submitting the Commodity (Fee-for-Service) pricing?

23. **QUESTION:** Are there any pallet restrictions?
- ANSWER:** No

24. **QUESTION:** If a sample is requested, how much time will be allotted for delivery?

**ANSWER:** We would prefer that a delivery window of up to two weeks be provided to ensure sufficient time for processing and shipment of any requested samples.

25. **QUESTION:** Within what tab would we attach additional documents?

**ANSWER:** Please include additional documents within the tab they most closely match with. Please clearly mark each additional document with an appropriate heading or label.

26. **QUESTION: Section 27.0 Compliance with Specifications** Page 16: 27.6 States: Any deviations to the Specifications or Statement of Work must be clearly noted in detail by the Offeror, in writing, at the time of submittal of the formal proposal. Any deviations, alternations, or changes to the bid document or from the specifications as written may result in rejection of the Offeror's proposal or materials delivered.

The first sentence of this section states to clearly note in detail any deviations to the specification. The second sentence states any deviations from the specifications as written may result in rejection. Do we or do we not supply any deviations to specifications?

**ANSWER:** Any deviations to the Specifications or Statement of Work must be clearly noted in detail by the Offeror, in writing, at the time of submittal of the formal proposal, however, any deviations, alternations, or changes to the bid document or from the specifications as written may result in rejection of the Offeror's proposal or materials delivered.

27. **QUESTION: Section 12. Respondent Requirements** page 25 - You state: HCPS requires that participating respondents have been in the business for at least ten (10) years consulting on retirement plans. All respondents shall submit the number of years providing this type of service under the current business name and contact name on company letterhead. Respondent(s) who cannot demonstrate to the satisfaction of HCPS that they have had similar experiences or fail to provide this documentation may deem your proposal non-responsive.

Is this section supposed to be on this bid? If we don't comply with this will our proposal be deemed at non-responsive?

**ANSWER:** Please see Addendum #2 Item #3

28. **QUESTION: Section 18.2 Providers Responsibilities** page 29: You State: Any delivery stipulations or conditions (i.e. minimum order quantities) must be submitted, in writing, with the technical proposal. Include product description and stipulations or conditions. Example: minimum shipping weight, minimum shipping quantity, minimum dollar order, order lead-time, etc.. Then in Section 18.7 You State: HCPS reserves the right to reject proposals with minimum order quantities, if the minimum order quantity cannot be stored or the level of usage/movement of the product is low or not in accords with normal usage.

You ask for minimum order quantities and then you say you can reject proposals with minimum order quantities. Can you please clarify this?

**ANSWER:** We are requesting minimum order quantities to properly determine if HCPS can meet them. If HCPS will not be able to meet the minimum order quantities, we may need to reject those proposals because we won't be able to make those requirements match the needs of the HCPS Food & Nutrition program.

29. **QUESTION: Attachment H Professional Services Agreement Sample** —Please confirm if this needs to be submitted with the bid. Does the signature page of this agreement need to be signed when we submit bid?

**ANSWER:** Signature on the Professional Services Agreement Sample is not required as part of your offer. Signatures will be requested once notices of intent to awards are sent.

30. **QUESTION: Section 12 Respondent Requirements** page 25 – Do we need to supply our SAM'S certificate with our submission? If yes, what Tab should it be attached to in the Technical Submission?

**ANSWER:** No, HCPS will verify this information.

31. **QUESTION:** **Tab 4** – Experience of Manufacturer states we are to describe the Manufacturer’s experience with the Scope of Services requested here within. Pages 19-22 list the section on Scope of Services, exactly what are you looking for us to be detailed on when it comes to nutrition, buy American, etc?

**ANSWER:** In Tab 4 – Experience of Manufacture, please describe your Firms past experience providing these services and meeting the requirements of the commodity food programs.

Manufacturers should describe their experience as an USDA-approved commodity processor and how they meet the Scope of Services, including required nutrition standards and documentation. Summarize how Buy American compliance is ensured and how your operation supports the production and distribution expectations outlined in the RFP.

32. **QUESTION:** **Question on Attachment J/Cost Proposal Form:** For Price per Case Direct Discount, are you expecting net/commodity case price? For Price per Case refund/rebate, are you expecting gross/commercial case price?

**ANSWER:** Please see the revised cost proposal forms: Cost Proposal Form (Addendum #2 Attachment C) and Additional Item Availability Proposal Form (Addendum #2 Attachment D)

33. **QUESTION:** Do you use Commodity Banks to take advantage of Net Off Invoice allowances.

**ANSWER:** No, this RFP is for direct delivery to HCPS and will not be utilizing Net Off Invoice.

34. **QUESTION:** Are items awarded by the line or manufacture? Example, if Bongard’s cheese is awarded, could it be for one or two items or would all six items total to be awarded.

**ANSWER:** Please reference page 26, section 14 Award.

35. **QUESTION:** Would you like a presentation on our ordering system.

**ANSWER:** No, HCPS intends to submit Purchase Orders.

36. **QUESTION:** Are you planning to purchase your items directly through manufacturers or will you be ordering through private food distributors as well.

**ANSWER:** This RFP is for direct delivery from manufacturers.

37. **QUESTION:** Will HCPS allow split deliveries for large orders. Example, if an order is over capacity, will multiple deliveries be acceptable to fulfill the order.

**ANSWER:** Yes.

38. **QUESTION:** Will HCPS provide confirmation of receipt for emailed proposals beyond a read receipt?

**ANSWER:** Please reference page 29, section 20.

39. **QUESTION:** Which VPT method does HCPS want per line (Direct Discount vs Refund/Rebate vs any FFS exceptions)? The RFP mentions all three in different sections

40. **QUESTION:** Pricing- you will need the true case cost and the cost after any allowance from the manufacturers. Example, if this cheese is \$49 and there is a \$4.28 allowance the new total will be \$44.72. Is that what you are looking for or would you want the 4.28 in that column stating the refund/rebate?
